Met Opera on Demand High School Educational License Agreement

PRINCIPAL TERMS

The Metropolitan Opera (the "Met") hereby grants to the named Licensee certain limited access to the Met Opera on Demand subscription service ("MOoD") during the Term and in the Territory in accordance with the terms and conditions set out below and the MOoD Service Terms annexed hereto and made a part hereof. Certain capitalized terms are defined below and in the MOoD Service Terms. These Principal Terms and the MOoD Service Terms, collectively constitute and are referred to as the "Agreement."

Usage Grant: Private use by Authorized Users only. No other use is granted and, subject to paragraph 6 of the MOoD Service Terms, no other use is permitted. Licensee will ensure that all Authorized Users are made aware of limitations and restrictions on use.

The Term shall commence, and the License Fee shall be due, as of the Effective Date. The "Effective Date" shall mean October 1, 2020.

In the event of any inconsistency between the provisions of these Principal Terms and the MOoD Service Terms, the provisions of these Principal Terms will control, but only to the extent necessary to resolve the inconsistency.

MOoD SERVICE TERMS

By using the Met Opera on Demand service ("MOoD"), Licensee agrees to abide by the following terms and conditions of use:

1. Integration of Metropolitan Opera Terms and Conditions. Use of MOoD is governed by the terms of service applicable to the use of any of The Metropolitan Opera (the "Met") family of websites, which may be found at the following address: <http://www.metopera.org/user-information/terms-and-conditions/>, as modified by these MOoD Service Terms, which will govern to the extent of any inconsistency. The Met may change the terms of service applicable to The Metropolitan Opera family of websites at any time and Licensee's use including, without limitation, according Authorized Users the right to use the MOoD constitutes Licensee's agreement to the modified terms of service and all changes thereto. The most updated terms of service shall be made accessible through the Met website.

2. Certain Definitions. The following terms shall have the meanings ascribed below:

(a) "Authorized Users" are persons designated by Licensee who have agreed to access and use the MOoD in accordance with the MOoD Service Terms and are affiliated with Licensee or Institutions where the MOoD may be accessed as approved by the Met including Staff, Residents, students or others who have an official affiliation with Licensee or such Institutions. Licensee and the Met will cooperate in establishing adequate protocols for verified access to MOoD.

(b) "Content" means all text, audio, graphics, music, video and any other materials to which the Met may, from time to time, allow authorized access to through MOoD including content comprising operas performed at the Met. The Met shall have sole authority to curate Content available through MOoD and may remove or add Content in its sole discretion. It is understood that Content may include, at the Met's discretion, recognition to sponsors, underwriters and donors of the Met, including any such entities which have assisted in making Licensee's subscription to MOoD possible.

(c) "Institution Marks" the name, logos, trademarks or other identifying material of Licensee.

(d) "Met Marks" the name, logos, trademarks or other identifying material of the Met including, without limitation, the name or any logo of MOoD.

3. Limited License. The Met hereby grants Licensee a limited, nonexclusive license to accord Authorized Users the ability to access and use MOoD to view the Content for private non commercial exhibition, solely in accordance with these MOoD Service Terms during the Term. Licensee may not sublicense, assign, or transfer the License, and any attempt at such sublicense, assignment, or transfer is void and grounds for termination of this Agreement. Licensee may not sublicense or authorize access to MOoD (by allowing access) to anyone who is not an Authorized User. No Content shall be exploited by Licensee. All right, title and interest in and to the Content including, but not limited, any literary, music, artistic or creative material included therein and all exhibition, transmission and other rights in the Content, shall remain vested in and the sole and exclusive property of the Met. Licensee shall not have the right to use the Met Marks in any manner except as specifically approved by the Met hereunder in each instance. Licensee acknowledges that the Met Marks are valuable property rights of the Met and that any use thereof by Licensee without such written approval will constitute irreparable damage to the Met such that the Met shall be entitled to immediate entry of an injunction against such use.

4. Private Noncommercial Uses Only/ Rights Reserved. THE MOoD AND ITS CONTENT MAY ONLY BE USED BY AUTHORIZED USERS FOR NONCOMMERCIAL PRIVATE VIEWING BY MEANS OF STREAMING THROUGH THE MOoD SERVICE. PUBLIC PERFORMANCE OR COMMERCIAL USE (INCLUDING DISPLAYS, PERFORMANCES, REPRODUCTIONS AND DISTRIBUTIONS) OF MOoD AND ITS CONTENT, IN WHOLE OR IN PART, ARE STRICTLY PROHIBITED. ALL RIGHTS IN AND TO MOoD AND THE CONTENT AND ANY AND ALL ELEMENTS THEREOF NOT SPECIFICALLY GRANTED TO LICENSEE IS HEREBY EXPRESSLY RESERVED TO THE MET.

5. Prohibited Uses. No uses other than expressly provided for herein are permitted. Without limitation Licensee shall ensure that Authorized Users do not: (a) provide and/or authorize access to MOoD, such as through the sharing of passwords, to persons or entities other than Authorized Users; (b) download, record, print or make reproductions of Content, appearing on MOoD or comprising the Met Marks; (c) incorporate Content into other content or materials of any kind; or (d) attempt to override, circumvent, or disable any encryption features, software, anti piracy or access protections employed by MOoD.

6. Fair Use, Educational, and Other Exceptions to Copyright Laws. Nothing in this Agreement should be construed or interpreted to limit those uses of Content printed, exported or displayed from MOoD that are permitted under the fair use, educational exceptions, or other provisions to the copyright laws or other intellectual property right laws in the US or other countries covered by this license if any ("Fair Use Law"), but Licensee and any Authorized User who makes such uses does so at their own risk.

7. Maintaining Security of MOoD. Licensee is responsible for maintaining the confidentiality and security of access to the MOoD service and for all usage or activity by Authorized Users and Licensee agrees not to provide access to MOoD to anyone else (other than as may be expressly permitted by the Met in its sole discretion). Licensee shall promptly notify the Met of any known or suspected unauthorized use(s) of MOoD, or of any known or suspected breach of security, including loss, theft, or unauthorized disclosure or user password, and/or login credentials (if applicable). Any use of MOoD beyond the scope or in violation of these MOoD Service Terms, knowing access to persons other than Authorized Users, or any fraudulent, abusive, or otherwise illegal activity, may be grounds for termination of this Agreement and/or Licensee's account, or termination of access to the MOoD. The foregoing includes but is not limited to activity by Licensee that may burden or overtax MOoD's server(s) such as computer programs that automatically request service, stream download or export Content, commonly known as web robots, spiders, crawlers, wanderers or accelerators.

9. Disclaimers. MOoD IS PROVIDED "AS IS" AND WITHOUT WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED. TO THE FULLEST EXTENT PERMISSIBLE PURSUANT TO APPLICABLE LAW, THE MET DISCLAIMS ALL WARRANTIES INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, TITLE, NONINFRINGEMENT OF INTELLECTUAL PROPERTY AND FITNESS FOR A PARTICULAR PURPOSE EXCEPT AS MAY OTHERWISE BE SPECIFICALLY STATED HEREUNDER. THE MET DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED ON MOoD OR IN OR IN RESPECT OF ANY CONTENTS WILL BE UNINTERRUPTED OR ERROR-FREE, THAT DEFECTS WILL BE CORRECTED, OR THAT THE WEBSITES OR THE SERVER(S) THAT MAKE MOoD AVAILABLE ARE FREE OF VIRUSES OR OTHER HARMFUL OR DESTRUCTIVE COMPONENTS. NOR DOES THE MET WARRANT OR MAKE ANY REPRESENTATIONS REGARDING THE USE OR THE RESULTS OF THE USE OF THE CONTENTS IN TERMS OF ITS CORRECTNESS, ACCURACY, RELIABILITY, OR OTHERWISE..

LICENSEE EXPRESSLY AGREES THAT THE MET SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY LOSS OR DAMAGE WHATSOEVER, DIRECT, INDIRECT, CONSEQUENTIAL, PUNITIVE, ACTUAL, INCIDENTAL, SPECIAL OR OTHERWISE,

INCLUDING, WITHOUT LIMITATION, LOSS OF PROFITS, BUSINESS INTERRUPTION OR LOSS OF INFORMATION, ARISING OUT OF THE USE OF OR INABILITY TO USE MOoD OR THE CONTENT, IN WHOLE OR IN PART. BY USING MOoD AND MAKING MOoD AVAILABLE TO AUTHORIZED USERS PURSUANT TO THIS LICENSE, LICENSEE WAIVES ANY CLAIMS LICENSEE MAY HAVE AGAINST THE MET WHICH MAY RESULT FROM USE OR INABILITY TO USE MOoD. IF LICENSEE IS DISSATISFIED WITH MOoD OR ANY CONTENT, LICENSEE'S SOLE AND EXCLUSIVE REMEDY IS TO DISCONTINUE USING MOoD OR ACCESSING THE CONTENT. BECAUSE APPLICABLE LAW MAY NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, THE EXCLUSION THEREOF MAY NOT APPLY TO LICENSEE, BUT WILL, IN ANY EVENT, APPLY TO THE MAXIMUM EXTENT PERMISSIBLE, AND IN NO EVENT SHALL THE METROPOLITAN OPERA'S TOTAL LIABILITY TO LICENSEE FOR ALL DAMAGES, LOSSES AND CAUSES OF ACTION (WHETHER IN CONTRACT, TORT (INCLUDING BUT NOT LIMITED TO NEGLIGENCE) OR OTHERWISE EXCEED THE AMOUNT PAID BY LICENSEE FOR ACCESSING MOoD AND ENABLING AUTHORIZED USERS TO ACCESS MOoD IN RESPECT OF THE TERM .

IT SHALL BE A CONDITION OF THE ACCESS GRANTED TO MOoD TO ANY AUTHORIZED USER, THAT THE AUTHORIZED USER ACCEPT THESE MOoD SERVICE TERMS INCLUDING, WITHOUT LIMITATION, THIS LIMITATION OF LIABILITY TO THE FULLEST EXTENT PERMITTED BY LAW.

10. Privacy Policy. Use of MOoD indicates acceptance by Licensee and all Authorized Users of the Met's Privacy Policy, as it may be amended from time to time and which is available at <http://www.metopera.org/user-information/privacy-policy/>. MOoD's Privacy Policy provides in part that the Met may disclose information about usage of MOoD and demographics pertaining thereto so long as such disclosure does not reveal users' personal identities, unless such disclosure is required to protect against violations of this License, or to protect and defend the Met's rights or property, or the rights or property of third-party rights holders and contributors to MOoD, or is reasonably necessary for pursuing a claim or investigation concerning alleged violation(s) of the Service Terms or is in response to a subpoena, court order, or other legal proceeding. Authorized Users may be asked if they wish to be contacted directly by the Met and/or to provide information to the Met which the Met may use for research and marketing purposes.

11. Representations, Warranties, Indemnity. Licensee represents and warrants that (a) it has the right to enter into and fully perform this Agreement; (b) it will not incur, undertake or make any representation, warranty, covenant or agreement on behalf of the Met to or for any person, firm or corporation; (c) it will fully perform all obligations, agreements and covenants made herein. Licensee shall indemnify, defend and hold the Met harmless from any and all claims, damages, liabilities, costs or expenses (including reasonable attorneys' fees) arising out of any breach of any warranty, undertaking, representation or agreement made by Licensee herein.

12. Termination.

(a) The Met may at any time (without prejudice to any other rights or remedies which the Met may have) by giving notice to Licensee, terminate the Agreement for good reason, in any of the following events: (i) if Licensee shall exploit any Content in any manner or media not expressly permitted hereunder, including, without limitation any access granted to the Content to any person or entity not comprising an Authorized User to have access to MOoD, (ii) if Licensee shall alter any Content; or (iii) if Licensee shall commit or permit to be committed any other breach or default of any of the terms, conditions and warranties, contained herein which is not cured within five (5) days after notice thereof by the Met (unless such breach is of a provision previously breached by Licensee in respect of which the Met has already given Licensee notice, in which event Licensee shall not have the right to cure the breach).

(b) The Met shall also have the right to terminate this Agreement at any time for convenience, upon written notice to Licensee.

13. Miscellaneous. (a) Neither the rights herein granted to Licensee, nor this Agreement, may be assigned or sublicensed by Licensee without the prior written consent of the Met. Any assignment or sublicense in contravention of the foregoing shall be deemed null and void ab initio.

(b) If any provision hereof shall be found to be contrary to any applicable government, provincial, state, federal or municipal law or regulation of any government, province, state, federal or municipal administrative agency or body, the same shall not affect the other provisions hereof. It is hereby acknowledged that this Agreement represents the sole and entire understanding between the parties and any modification shall only be binding on the Met and Licensee if reduced to writing and signed by both the Met and Licensee.

(c) Any notice required hereunder shall be sufficiently given if forwarded by certified or other official mail, return receipt requested, addressed to the Met or Licensee at its address first set forth above, with a copy by e-mail to the Met to MBongiovanni@metopera.org.

(d) This Agreement shall be construed in accordance with the laws of the State of New York applicable to agreements made and to be wholly performed in such state. The parties consent to the sole and exclusive jurisdiction of the state and federal courts of the United States and the State of New York located in New York County, New York, in the U.S.A. in connection with the adjudication of any dispute arising hereunder.

(e) This Agreement may be executed in counterparts, all of which taken together shall be deemed one original. For the purposes of execution, a facsimile signature or a signature otherwise scanned and transmitted electronically by computer file (e.g., .PDF, .GIFF, .JPEG, .TIFF, .BMP, etc.) shall be deemed as valid as an original.
