As you know from our prior correspondence, this firm represents Mary Ruth Bullock in her capacity as Personal Representative of the Estate of Eva L. Karroll.

The Personal Representative wishes to make a Partial Distribution of the Estate of Eva L. Karroll. The Personal Representative is still in the process of administering this Estate and has several tasks to accomplish, including the sale of the residence. As a result, the Personal Representative must reserve sufficient funds to pay for all expenses necessary to maintain the residence until is sold and to bring administration to a conclusion.
